Resolution No. FY2021-01

A RESOLUTION ADOPTING PREVAILING RATE OF WAGES FOR PUBLIC WORKS

WHEREAS, the State of Illinois has enacted the "Prevailing Wage Act", 820 ILCS 130/1 et seq. (the "Act"); and

WHEREAS, the Act requires that the LEMONT PUBLIC LIBRARY DISTRICT investigate and ascertain the prevailing rate of wages as defined in the Act of laborers, mechanics and other workers in the locality of the District employed in performing construction of public works for the District.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE LEMONT PUBLIC LIBRARY DISTRICT:

SECTION 1: To the extent and as required by the Prevailing Wage Act, the general prevailing rates of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the LEMONT PUBLIC LIBRARY DISTRICT is hereby ascertained to be the same as the prevailing rate of wages for construction work in Cook and DuPage Counties as determined by the Department of Labor of the State of Illinois as of July of the current year. Copies of said determinations are attached hereto and incorporated herein by reference.

As required by the Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's July determination and apply to any and all public works construction undertaken by the LEMONT PUBLIC LIBRARY DISTRICT. The definition of any terms appearing in this ordinance which are also used in the Act shall be the same as the Act.

LEMONT PUBLIC LIBRARY DISTRICT

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment, except public works construction of the LEMONT PUBLIC LIBRARY DISTRICT to the extent required by the Act.

SECTION 3: The President of the LEMONT PUBLIC LIBRARY DISTRICT shall publicly post or keep available for inspection by any interested party in the main office of the District this determination or any revisions of such prevailing rate of wage. A copy of this determination, or of the current revised determination of the prevailing rate of wages then in effect, shall be attached to all contract specifications.

I further certify that said ordinance has not been amended or repealed but remains in full force and effect at this time.

SECTION 4: The President of the shall mail a copy of this determination to any employer and to any association of employers, and to any person or association of employees who have filed their names and addresses requesting copies of any determination, stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The President of the LEMONT PUBLIC LIBRARY DISTRICT shall promptly file a certified copy of this Resolution with the Secretary of State of Illinois, Index Division and the Illinois Department of Labor, Fair Labor Standards Division.

SECTION 6: Within thirty days after filing with the Secretary of State, the President of the LEMONT PUBLIC LIBRARY DISTRICT shall cause to be published in the newspaper of general circulation within the area, a copy of this Resolution. Such publication shall constitute notice that the determination is effective, and that this is the determination of this public body.
