Public Notice of Ordinance No. FY2022 – 02


An Ordinance to Levy and Access a Tax for The Lemont Public Library District of the Counties of Cook and DuPage, State of Illinois for the Fiscal Year Beginning July 1, 2021 and Ending June 30, 2022

BE IT ORDAINED, that the Lemont Public Library District of the Counties of Cook and DuPage and State of Illinois shall levy a tax of .02% of the value of all taxable property within said District, for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen (15) days from the date of adoption of the ordinance, it shall be published in the Lemont MySuburban Life, a newspaper of general circulation in the Lemont Public Library District and it is effective immediately upon adoption.

IN WITNESS WHEREOF, we have hereunder set our hands un Lemont, Illinois this 13th day of July, 2021.

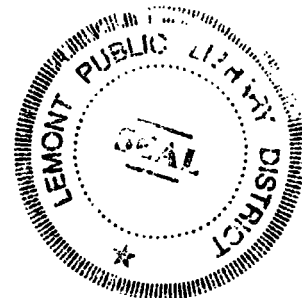


